Action: Newly Measures Suggested and To Be Enforced by Communication VC

### **I. Within SC:**

- 1. Statistics: To prepare weekly report of all activities for SC members in order to tightly hold all SC members together, and to project a clearer picture to the team as basis for better planning and implementation.
  - A. Weekly Report by VC (Communication):
    - i. Send out every Friday;
    - ii. Include upcoming activities organized / jointly organized by Convocation in the coming week;
    - iii. Include past activities in the week;
    - iv. Activities include meetings, events, ceremonies, etc.;
    - v. Include any circulating documentations for decision with results.

#### II. To All Alumni Members:

- 2. Convocation Identity: To standardize all publicity in order to give a clearer and distinctive image to the public.
  - A. Letterhead: To include a designed letterhead for all outgoing mail, email, SC meeting papers and documents. Letterhead should include the

- Convocation Logo and CityU Logo; the mailing address; telephone; fax; website; and email;
- B. Name card: For re-print name card, include Convocation Logo and CityU Logo;
- 3. Alumni Video Stories: To prepare one-minute video story for individual alumnus in order to engage over 100,000 alumni members in our community.
  - A. Inform well interviewee of the details and interviewing questions;
  - B. Inform well interviewee the posting of the video clips on alumni websites including Convocation alumni community;
  - C. On two occasions: Alumni stories video taken at any place at any time; Participants feedback video participants attending Convocation activities.
